Preparation

1. Ensure the product is well mixed before using as settlement can occur.

Application

- The liquid can be added to the dry mix or to the gauging water.
- To obtain the required colour Sealocrete Sealotone Liquid should be used at the addition rate/dosage stated.
- 3. The type and colour of both cement and sand affect the final colour achieved. Use colour of sand closest to the desired final colour. Use the same grades and weights of cement and sand for the whole project. The same quantity of gauging water must be added to each batch.
- 4. It is recommended to carry out trial mixes to determine the optimum addition rates for the required colour. Always assess colour match on a set, dry mix.
- Avoid over-trowelling and never disturb the set once it has taken place.

Precautions in Use

Sealocrete Sealotone Liquid cannot be used as a surface stain and must always be incorporated into a cement based mix. To ensure colour consistency, ensure product from the same batch is used. Product should be transported safely, upright and the lid should be fully closed. Do not use more than one admixture in mixes incorporating Sealocrete Sealotone Liquid.
